In consideration of Iberville Parish Government, through the Iberville Parish Firing Range (“Range”) furnishing services, equipment, and/or facilities, and in consideration of my participation in firearm shooting and other related activities (the “Sport”), I agree as follows:

I understand and acknowledge that:

- a. The sport involves inherent risks and dangers associated with the use of firearms and related equipment.
- b. My participation in the Sport, use of Sports equipment, and/or presence at the Range may result in damage to or loss of personal property, serious bodily injury, permanent disability, or death.
- c. These risks and dangers may be caused by my own actions or inactions, the actions or inactions of others, negligence of Iberville Parish Government or its officers, directors, employees, agents, or representative, equipment failure, accidents, forces of nature, or other foreseeable or unforeseeable causes.
- d. I voluntarily assume all risks, known and unknown, associated with my participation in the Sport and my presence at the Range.
- e. I understand that instruction or guides are recommended for all beginners.
- f. I acknowledge that I have read, understand, and agree to follow all course rules, guidelines, and posted regulations of the Iberville Parish Firing Range.

I acknowledge and agree to strictly follow these fundamental firearm safety rules at all times while on Iberville parish Firing Range property:

- Always keep the firearm pointed downrange and/or in a safe direction
- Always keep the firearm unloaded, including the magazine and breech, until ready to shoot
- Always keep my finger off the trigger until ready to shoot
- Always know my target and what is beyond it
- Do not handle firearms at any time when persons are downrange.

I understand that any violation of these safety rules or Range regulations may result in immediate removal from the premises and/or forfeiture of shooting privileges, without refund or recourse.
